## LETTER OF AGREEMENT

Sponsorship of \_\_\_\_\_  
*[Corporate Partnership or Name of Event]*

Thank you for your sponsorship and support. The purpose of this letter is to confirm the sponsorship arrangements, which are set out below, employing the terms with the meanings.

1. Sponsorship is due upon receipt and payable prior to the event date.
2. The sponsorship amount is net of any taxes, which if due, will be paid by the sponsor.
3. Sponsorship is a business expense and therefore a charitable tax receipt cannot be issued.
4. The sponsor must deliver any sponsor materials to CSAE BC by a set due date or dates previously agreed to.
5. The sponsor grants to CSAE BC a non-exclusive license to use the sponsor logo(s) in the CSAE BC event promotion and membership materials, but only for the purpose of conferring the sponsorship benefits in relation to the event. Any materials that are provided to or created by the CSAE BC pursuant to this agreement are the property of the CSAE BC.
6. CSAE BC must use the sponsor logo(s) in the colours and font type as per the sponsor's branding guidelines/policy.
7. CSAE BC will duplicate the sponsor logo(s) in such size and prominence as CSAE BC reasonably decides, having regard to:
  - a) The size of the location where it will be used;
  - b) The relative size of the logos of other sponsors; and
  - c) The sponsor's and other sponsors' comparative level of sponsorship.
8. The sponsor warrants that:
  - a) It is the owner of the logo(s); and
  - b) It is entitled to grant a license of those registered logo(s) in accordance with this agreement.
9. The sponsor warrants that the sponsor logo(s) do not infringe the rights of another person and/or organization.
10. The sponsor indemnifies CSAE BC from and against all actions, claims, proceedings and demands arising from any claim that a logo infringes the rights of another person and/or organization.
11. Neither party may assign or sub-contract this agreement, or any rights or obligations in this agreement without the other's prior written consent.

- 12. Either party may terminate this agreement without cause on giving 30 days' written notice of termination to the other party. The sponsor agrees that, in the event of any termination of this agreement by the sponsor, no refunds shall be given under any circumstances.
- 13. This agreement is governed by the laws of British Columbia.
- 14. No modification of this agreement is effective unless it is in writing and signed by the parties.
- 15. The agreement may be entered into by each party signing a separate copy of this agreement (including a photocopy or faxed copy) and delivering it to the other party in person by fax or scanned copy.
