



2018 CSAE Trillium Emerging Talent Award – Executive Member Deadline to receive nomination: Friday, May 25, 2018

CSAE Trillium is accepting nominations for the presentation of the Emerging Talent Award. This award will be presented to one CSAE Trillium Executive Member who, **within the first five years of the members' careers in the association sector, or within the first five years of CSAE membership**, has demonstrated remarkable promise as future leaders in the association sector.

Do you know a colleague or volunteer who exemplifies qualities of leadership, creativity and overall outstanding talent within the association sector? If so, here is your chance to recognize his/her efforts.

ELIGIBILITY

All CSAE Trillium Executive Members, in good standing, holding CSAE membership at the time of the nomination are eligible for this award. Current members of CSAE Trillium Council are not eligible for nomination.

SELECTION CRITERIA

The following criteria are considered in determining a recipient:

- **LEADERSHIP:** The individual has demonstrated qualities that hold remarkable promise as future leaders in CSAE Trillium or the association sector.
- **CREATIVITY:** The individual has shown some creativity through his/her work in the association sector or volunteer work with CSAE Trillium.
- **OUTSTANDING TALENT:** The individual has been able to demonstrate outstanding talent in his/her first five years in the sector, or in the first five years of CSAE membership.

The Membership Committee will review all nominations in consideration of the selection criteria stated above and will recommend this year's recipient to the CSAE Trillium Council, which has final approval on the recommendation. In the event that no nominee meets the criteria, no award will be presented.

PRESENTATION

The 2018 CSAE Trillium Emerging Talent Awards will be presented at the Awards Gala on October 11, 2018 immediately following CSAE Trillium Annual Update.
