All Executive members, in good standing, holding CSAE membership at the time of the nomination are eligible for this award. Current members of CSAE Trillium Council are not eligible for nomination.			
SELECTION CRITERIA			
The following criteria are considered in determining a recipient:			
➤ INVOLVEMENT:	The individual has been involved in CSAE Trillium through activities, committees and/or programs.		
➤ LEADERSHIP:	The individual shows qualities that exemplify leadership and inspiration related to participation in CSAE Trillium or the association sector.		
➤ INNOVATION:	The individual exemplifies innovation in association management.		
➤ ACHIEVEMENTS:	Any notable achievements in their association, community, the province or country.		
The Membership Committee will review all nominations in consideration of the selection criteria stated above and will recommend this year’s recipient to the CSAE Trillium Council, which has final approval on the recommendation. In the event that no nominee meets the criteria, no award will be presented.
